NCBW Tampa Bay Chapter Launches Advocacy Toolkit to Educate and Activate Community

"The goal is for community members to use the advocacy toolkit to fight for a greater society for themselves and future generations to come. Our voices matter but our action is even better. It's time to fight to win!"
